

REGISTRATION AND TUITION

TO REGISTER: Mail, fax, or drop-off completed forms with payment to Dance Center Evanston, Evanston Plaza, 1934 Dempster St., Evanston, IL 60202. Fax number is (847) 328-6656. You may pay by cash, credit card (Visa, Mastercard, or Discover), or check payable to Dance Center Evanston. (Checks save DCE over 2% in credit card fees.) Please fill out a separate form for each student. Photo copies are acceptable.

Returning Student Registration begins August 16, 2010, 9 am. Forms received before the 16th will be processed in random order on the 16th. For walk-in registration on the 16th, each adult may only register their own family, plus one other family.

New Student Registration begins August 25, 2010, 9 am. Forms received before the 25th will be processed in random order on the 25th.

BASE TUITION for 45-60 minute classes except Pointe: (Base tuition reflects an escalating discount for multiple classes per week.)

ADULT TUITION: as above, or:

Single class, 45-60 minutes: \$14

ANNUAL REGISTRATION FEE: \$25 for the first child, regardless of discount, and \$15 for each additional sibling.

FAMILY DISCOUNT: When 2 or more children from the same family register at the same time, there is a 10% discount applied to the entire tuition, less registration fees. Students using the tuition cap do not receive a family discount.

PAYMENT PLAN: Credit card number or postdated checks are required at time of registration. Fee for payment plan is \$10 for Session 1, \$15 for Session 2. Checks should be postdated for, or credit card will automatically be deducted on, the following days:
